- Payments will be credited to the account on the date post marked on the envelope. Payments received with no post marking will be credited on the date received.
- Late payment charges of 4% compounded monthly (60.00% per annum) will be applied to overdue balances. Items returned due to insufficient funds are subject to a \$35.00 administration charge.
- Failure to remit payment for quarterly bill statements by the stated due date will result in the suspension or cancellation of all tutoring services.
- Overdue accounts in excess of 6 months will incur additional charges and administrative fees. All costs associated with the collection of an overdue account, including but not limited to debt collection services, legal fees and courier costs, will be incurred by the registering parent/guardian.

II. Cancellations, Missed Appointments, and Rescheduling
